

#### ICCF Awards Grant for Community Garden Project

Many Iosco County residents had the opportunity to plant their own gardens over the summer through the East Tawas Community Garden Project. ICCF provided a \$690





The goal of the project was to make the garden more accessible and inclusive for gardeners of all ages and abilities to have a garden, therefore also helping them to produce their own healthy, nutritional food. The raised beds and trellises have made it easier for

older individuals to work in their gardens because they don't need to crouch or bend in order to tend their plants.

Through the garden project, families have free use of individual plots to plant and harvest with the assistance and coaching of gardeners from the Sunrise Side Master Gardener Association.

# Grants Provide Baby Pantry Necessities



According to the 2008 Kids Count survey, 27% of Iosco County children are living in poverty. To help the parents of those children who are newborns, and up to age 3, baby pantries in Iosco County are working to provide the essentials for families, particularly those with young mothers.

Two grants from the Iosco County Community Needs Fund were awarded to help local pantries. The Hale Area FISH's Hale Baby Pantry and Carol's Baby Pantry (through the Iosco County Child Protection Council) received a total of \$1,500 in grants to purchase baby food, formula, diapers and clothing for children. Combined, the two agencies were able to assist more than 280 families in Iosco County. With the help of donations, grant funding and the time of volunteer workers, the Hale Baby Pantry and Carol's Baby Pantry hope to be able to help even more families next year.

"Several of our grants this year were aimed at lessening the burden on some of Iosco County's families who have been hit the hardest by the economic downturn," said Chad Brandt, ICCF Board President. "That ICCF's grants are able to meet needs like these, in addition to funding all types of programs, is a real asset to our communities."

#### ICCF Strategic Goal Update

The ICCF Board has been working diligently to achieve three objectives identified in a strategic planning session held in late 2009. Those goals were to increase unrestricted assets by \$10,000 by the end of 2011; to build the ICCF Board of Directors with representation from across Iosco County; and to increase public awareness of the Community Foundation. In achieving these goals, the ICCF Board believes they will be able to better serve Iosco County's nonprofits, residents and visitors.

As a result of their efforts in 2011, ICCF's unrestricted assets have increased by over \$8,100; A new trustee, Cliff C. Miller—has joined the Board as a representative from the Tawas area; and the ICCF Board members have been representing the Community Foundation at local events (including the Iosco County Fair, Oscoda Business Expo and local high school graduation events).

#### Applying for Grants

The Iosco County Community Foundation accepts grant applications during the year for various types of programs throughout Iosco County. All grants are awarded to 501(c) (3) nonprofit organizations, schools, churches (for non religious purposes), or government agencies.

#### Common Grants

Awarded to a wide variety of charitable programs throughout Iosco County.

Deadline: May 1

#### Youth Advisory Council (YAC) Grants

Awarded to projects and programs benefiting youth under the age of 18 in Iosco County. These grants are reviewed and awarded by ICCF's Youth Advisory Council (YAC) - a group of youth from across Iosco County.

Deadline: February 28

The maximum request amount for Common Grants is \$1,000. Youth Advisory Council Grant applicants may request up to \$2,500. See the ICCF website for more information.

### **Unrestricted Giving Helps ICCF Make Broad Impact**

Unrestricted funds, such as the Iosco County Community Needs Fund, allow the Community Foundation to award grants to a broad range of programs, and provide the ability to meet needs in the community as they change. Currently ICCF has 35 endowment funds—only two are unrestricted. Willyard said she hopes to see more of these funds established, as well as additional gifts to the current ones.

Field of Interest funds, such as the Iosco County Arts and Humanities Fund and the Iosco County Lakes and Rivers Fund, give donors the opportunity to direct their gift toward a specific area of interest, but still give the Community Foundation flexibility in awarding grants.
