## ICCF Honors First Iosco County Philanthropist of the Year

In May 2012, the Iosco County Community Foundation presented its first-ever Iosco County Philanthropist of the Year award. Daniel Stock, of Oscoda, was chosen as the 2012 recipient of the honor, which is awarded to local residents who have given their time, talents and resources for the betterment of their community.

25 people, including Mr. Stock's family, friends, members of organizations for which he volunteers, the ICCF board and staff attended a luncheon where the award was presented.

Mr. Stock has been active in the Oscoda area since moving there in 1996. Throughout the past 16 years Mr. Stock has worked with the Pine River/Van Etten Lake Watershed Coalition (PRVEL), the Alcona-Iosco

Conservation District, the Oscoda Area United Way, and the Iosco-Arenac District Library, and has supported numerous other organizations both financially and through volunteerism.

The Philanthropist of the Year Award is not meant to just single out someone who makes a large amount of financial contributions. The ICCF board wants to honor someone each year that is generous with their time, talents and financial resources with a goal of making a difference. Mr. Stock truly represents the real meaning of being a philanthropist.

## Large Bequest Provides Opportunity for Art Students

Iosco County residents who choose to follow a career path for the visual arts have the opportunity for significant help with funding for their education thanks to a large gift to the Michael Wentworth Memorial

The scholarship fund through ICCF was the recipient of an \$846,000 bequest from the Estate of George Gravert. Mr. Gravert wanted to ensure that the fund was large enough to really help students in Iosco County who are planning on a career in the visual arts.



Residents of Iosco County who will be attending an accredited college, university or non-profit organization apprenticeship to study in the field of architectural design, drawing, painting or art history are eligible for the scholarship.

"This scholarship fund is capable of making a real difference in the lives of area students who show a genuine interest in pursuing a career in the fields chosen by Mr. Wentworth and Mr. Gravert," said ICCF President Tony Johnson.

## Applying for Grants

The Iosco County Community Foundation accepts grant applications during the year for various types of programs throughout Iosco County. All grants are awarded to 501(c)(3) nonprofit organizations, schools, churches (for non-religious purposes), or government agencies.

#### Common Grants

Awarded to a wide variety of charitable programs throughout Iosco County.

Deadline: May 1

#### Youth Advisory Council (YAC) Grants

Awarded to projects and programs benefitting youth under the age of 18 in Iosco County. These grants are reviewed and awarded by ICCF's Youth Advisory Council (YAC) - a group of youth from across Iosco County.

Deadline: February 28

The maximum request amount for Common Grants is \$1,000. Youth Advisory Council Grant applicants may request up to \$2,500. See the ICCF website for more information.

Grant applications are available for completion and submission online at www.iccf-online.org. Mini-grant applications are also available online, but must be mailed to the ICCF office.

### **Unrestricted Giving Helps ICCF Make Broad Impact**

Unrestricted funds, such as the Iosco County Community Needs Fund, allow the Community Foundation to award grants to a broad range of programs, and provide the ability to meet needs in the community as they change. Currently ICCF has 35 endowment funds—only two are unrestricted. Willyard said she hopes to see more of these funds established, as well as additional gifts to the current ones.




